Letter from **PROF BROODRYK**

Associate Professor and Managing Attorney of the SU Law Clinic

As I reflect on the year that's been, I am filled with a sense of pride and immense gratitude. As this report demonstrates the Clinic has been able to give

effect to its vision of a legally empowered community, professionally trained law graduates and a broader South African community that is sensitised to their social justice responsibilities. I highlight some of the Clinic's 2022 activities and achievements below.

Recently, from 11-15 December 2022, the Clinic joined the Faculty of Law in hosting the Global Alliance for Justice Education (GAJE) 11th Worldwide Conference in collaboration with the International Journal of Clinical Legal Education (IJCLE) and the South African University Law Clinics Association (SAULCA). The theme of the conference was "Justice Education: Building Resilience and Strong Connections in Times of Global Challenges".

Our financial literacy and constitutional rights training projects continue to be well received. The Financial Literacy Project is an annual initiative which aims to empower our surrounding communities (schools and farms) with essential financial literacy skills. The project is coordinated by one of our attorneys, Josie Parks, who was assisted by our candidate legal practitioners, Theo Opperman, Itumeleng Mashego and Stephanie O' Reilly. The training is conducted by third year civil procedure students of the Faculty of Law and financial planning students currently enrolled at the EMS Faculty of Stellenbosch University. The training deals with issues such as the importance of a good credit score, the effects of being over-indebted, the benefits of saving, and certain rights contained in the Consumer Protection Act. This year, we conducted five sessions through which we reached approximately 800 individuals. From 17 October to 5 November 2022, the Clinic continued with its constitutional rights training project in terms of which we provide training to numerous vulnerable and marginalised communities across different provinces in South Africa. The sessions were conducted by the Clinic's Odwa Nweba and Stephanie O'Reilly. We visited KwaMakutha and Mpophomeni in KwaZulu Natal, Duncan Village in Eastern Cape, Thohoyandou and Mankweng in Limpopo and KwaMhlangu in Mpumalanga. Close to 200 individuals attended with many more benefitting from these sessions.

The Clinic recently hosted a delegation of staff and students from Strathmore University Law Clinic, Nairobi, Kenya. Our colleagues from East Africa conducted a benchmark exercise to gather information to improve their own clinical program and we were very pleased to have been able to assist in this regard. We also hosted a group

of intern students from Hasselt University in Belgium for a 6-week period. The primary aim of the programme is for interns to experience, first-hand, the workings of a South African law firm. Interns were assigned to student firms, consisting of final-year law students enrolled for the Practical Legal Training module at the Faculty of Law. Interns observed student consultations, took part in mock consultations facilitated by the Clinic's consultants, and ultimately conducted their own consultations with the Clinic's clients. Consultations took place at one of numerous consultation rooms in the Clinic's offices in Stellenbosch and, once per month, at the Clinic's Ceres and Worcester satellite offices. Interns also accompanied the Clinic's attorneys and candidate legal practitioners to observe appearances at courts and tribunals.

From an impact litigation perspective, the Clinic successfully opposed numerous appeals, up to the Supreme Court of Appeal, of the decision to certify its consumer class action involving the Lifestyle Direct Group International. The matter has now been appealed to the Constitutional Court. We are confident that we will be able to launch the class action during 2023. The certification of the Clinic's class action application on 21 July 2021 is groundbreaking for a number of reasons: it represents only the tenth South African class action to be certified successfully, as well as the first successful class action certification by a South African university law clinic, and the first opposed consumer law class action to be certified.

There were also many pleasing developments among our staff. Dr Stephan van der Merwe graduated with a Doctor of Laws and Nikita Stander obtained her Master of Laws (by research). The Clinic is also very proud of two of our candidate legal practitioners, Stephanie O 'Reilly and Elandré van der Gryp, who recently received confirmation that they passed all their attorney admission examination papers.

These are just some of the highlights of the year in review. The Clinic's successes and its ability to provide access to justice to poor, vulnerable and marginalised individuals, would not be possible without the continued support of the Faculty of Law and of our funders and stakeholders. We are indebted to them for enabling us to make a tangible difference in the lives of ordinary South Africans. A special word of thanks to the Dean of Law, Prof Nicola Smit. She is a visionary leader and one who is a massive proponent for social justice. Her support has been the bedrock to the Clinic's success.

Who we are

The Law Clinic's Vision is:

a community that is legally empowered and that possesses a strengthened capacity to exercise their rights, either as individuals or as members of the community; law graduates who are professionally trained and are at the highest echelons insofar as their employability is concerned;

To bring our vision into reality the Law Clinic, through collaboration initiatives or otherwise, provides professional legal advice and representation in civil matters to members of the community who qualify for legal aid in Stellenbosch and surrounding areas and we offer legal education, including clinical legal education, to candidate attorneys, final-year law students and to members of the community, including the poor and marginalised. - To promote strong governance and management structures; and
- To sustain the Law Clinic's existence and its ability to offer relevant, cost-effective services.

Through the fulfilment of these objectives, the Law Clinic contributes towards the University's overarching strategic imperatives by ensuring that it, firstly, remains committed to the broadening of access by being responsive to the needs of its beneficiaries, particularly those in vulnerable communities; by increasing and accelerating the diversity profile of Law Clinic staff through proactive recruitment; developing and retaining Law Clinic staff members from the designated groups; and creating an inclusive Law Clinic culture and climate that embraces diversity and the values of the University; secondly, delivers work of an excellent standard in every facet of its operation by implementing appropriate accountability mechanisms and reporting structures within the organisation; and lastly, strives to achieve maximum societal impact within its sphere of influence by responsibly and thoughtfully conducting operational and strategic processes; reviewing progress regularly; and being responsive to the ever-changing context in which it operates.

How we are

Managed & Governed

he Law Clinic is governed by its Advisory Board and the elected SU Council. The Law Clinic's strategy is influenced by decisions taken by the governing structure of SU and is shaped by the Manager, the Dean and Vice-Dean of the Law Faculty, with the input of the Law Clinic attorney employees and the Faculty Committee, subject to the overall SU strategy, policies, procedures and rules. The Manager is a member of the Law Faculty's executive decision-making body, the Faculty Committee. Certain decisions are also subject to approval by the Faculty Board, which mostly comprises all permanent academic faculty appointments. The Faculty's decisions are subject to the governing structures policies, procedures and rules and such decisions would accordingly need to be made with due reference to such governance instruments. The governing structure's approval regarding certain decisions affecting the Law Clinic's strategy may be required and it may also be approached on an ad hoc basis for input and advice. Financial reports are generated throughout the year and reviewed by internal SU mechanisms. The Law Clinic's annual budget is prepared by the Manager with input from Law Clinic practitioners and the Faculty Committee, subject to and within the framework of allocated SU organisational funding. The budget is approved by the Dean of the Faculty. An in-house financial management system is used by SU through which the funds of the Law Clinic are channelled and managed. SU practices effective, efficient and transparent financial management in terms of financial accountability. All financial transactions are subject to the University's Financial Policy. The signatory authority and mandate for approval resides with the Manager. Supporting documentation is required for auditing purposes.



894 individuals visited the Law Clinic




Impact Matters

Lifestyle Direct Group International

Su Law Clinic class action certification success: Su Law Clinic and others v Lifestyle Direct Group International and others. The application by Lifestyle Direct Group International and others to the Supreme Court of Appeal for reconsideration was dismissed, with costs. The matter has now been appealed to the Constitutional Court. We are currently awaiting judgment. If the appeal to the Constitutional Court is also dismissed (hopefully, once again, with costs), then the class action will finally commence.





Grobler v Phillips

The Clinic received judgment in one of our high impact matters in which our office opposed the eviction of an elderly client. After earlier successes in the High Court and Supreme Court of Appeal, the Constitutional Court judges unfortunately did not agree that our client should receive a permanent right of occupation in her current home. Nonetheless, under the circumstances of her having to leave her residence, we are grateful that the Court has made adequate arrangements for her subsequent relocation. Safeguarding the best interest of our clients, and protecting their rights, remains the Clinic's primary concern.






Media Coverage

Training in Northen Cape

n 12-14 July 2022, the Clinic's Odwa Nweba and Tsavo Raath - in collaboration with the Credit Ombudsman, Black Sash Trust, and the National Credit Regulator conducted community training in Pampierstad, Northern Cape. The training was based on the Debt, credit, and consumer rights manual, drafted by the Clinic, and the Clinic's constitutional rights program. The sessions were well received and attended by over 50 community members. We are delighted to be a role-player in this important community empowerment initiative and look forward to continued collaboration with our community service partners in expanding it to other communities.

Children's Rights Project

hank you to Legal Aid South Africa for enabling us to conduct a Children's Rights Project at primary schools in our local community. The project is aimed at educating young children, grades 1 to 3, on their rights in a fun and interactive way. The training is conducted by the Clinic's Candidate Attorneys. The children responded very enthusiastically, and the teachers were very appreciative. We would like to extend our sincere gratitude to all the participating schools without whom this initiative would not have been possible. With the support of our collaboration partners Legal Aid South Africa and some local schools, the Clinic recently conducted our second round of the Children's Rights Project for this year. The project is aimed at educating primary school learners in our local community about their rights in a fun and interactive way. We educated 319 learners about important topics including the right to family care, love and protection, the right to food and the importance of an education. The training was conducted by our Candidate Legal Practitioners, who also reminded these children about their right to feel safe and encouraged them to speak up if they do not feel safe. We appreciate the opportunity to enrich the minds of some of our most vulnerable and valuable members of society.













Wills Week

uring 4-5 October 2022, staff from the Clinic paid a visit to the Kylemore community to assist 53 people with the drafting of their wills. Although this service is offered at our office to qualifying clients throughout the year, this initiative has increased practical access to justice. Various elderly persons, those without any means of transportation as well as physically disabled persons were assisted in the process. We remain positive that we will be able to assist many other members of our surrounding communities through this initiative in the future.








Visit by Strathmore Law Clinic


